1. Introduction by the Director

The Institute for International Relations, since its founding in 1963 until now, regardless of several generations of researchers and several name changes, has preserved the continuity of interdisciplinary research in the field of the social sciences. Over the years we were engaged in a variety of topics, from international economic and political relations, European integration, economy and competitiveness, sustainable development and environmental protection, to cultural policy and media.

Excellent international networking and the interdisciplinary nature of our research enabled us to continue our work in 2010 on research topics related to current events in Croatia, the entire region of Southeast Europe, Europe and the world. The issues related to NATO and security issues, regional cooperation, accession negotiations with the European Union, regional and local development and cultural diversity and intercultural dialogue, environmental protection, nature protection and energy efficiency are just some of the topics to which we have given our scientific contribution throughout the year.

Scientific production of IMO's researchers in 2010 reflects their diverse engagements. In addition to the publication of 5 books, 15 book chapters, 43 papers in scientific journals and 8 invited lectures, our researchers are actively involved as lecturers at 24 courses in several Croatian universities and business schools. Two double issues of IMO's journal "Croatian International Relations Review" (CIRR) and the 14th edition of Culturelink Joint Publications Series were issued.

IMO currently employs 41 people, of which 31 are researchers (scientists, junior researchers and professional associates in science) and 10 are employees in supporting services. IMO has a wide range of regular contributors from Croatia and abroad who participate in the preparation and implementation of research projects of the Institute, at conferences and workshops.

Particular attention is paid to systematic education and scientific advancement of our employees. We follow and plan their career development, creating conditions for continuous education and specialisation in an international environment. In 2010 seven junior researchers have enrolled and regularly attend doctoral studies, and 11 researchers have advanced in scientific professions. Special attention was devoted to training in the preparation of international project proposals and to acquiring the skills of managing complex projects. For this purpose we have used the World Bank funds for the Science Technology Project in cooperation with colleagues from the Brodarski Institute in Zagreb.

In 2010 scientific research activity continued through the implementation of the

projects funded by the Ministry of Science, Education and Sports of the Republic of Croatia within the scope of two basic programmes: “International Aspects of the Knowledge Based Society - Integrations, Security, Economy and Environment” and “Promotion of Cultural Identities and the Process of Croatian Integration into the EU”. In addition, researchers have collaborated in the preparation and implementation of some 40 research projects for various clients and sponsors (international institutions and foundations, local and regional self-government units and government bodies) among which the European Commission, the EU Delegation in Croatia, the World Bank and UNDP should particularly be noted. By working on these projects, we made a contribution to the development of public policies in the Republic of Croatia and provided the scientific basis for the Government’s actions and its ministries, as well as other public bodies and institutions at national, regional and local levels.

We are especially proud of IMO’s partnership in FP7 project MEDIADEM “European Media Policies Revisited: Valuing and Reclaiming Free and Independent Media in Contemporary Democratic Systems” which examines the European media policies, and of the collaboration with the London School of Economics – LSE, in the implementation of the research project “Privatisation of Public Sector Services in Croatia and SEE: Assessment of the Major Gains and Pains” and the joint organisation and implementation of the regional conference “Regional Policy and Decentralisation in South East Europe” held in May in Zagreb. The publishing of the book “From Lisbon Strategy to Europe 2020”, supported by the EU Delegation in Croatia, was a joint effort of researchers from various IMO’s departments in finding answers to the challenges which EU and Croatia are facing in the period to 2020. IMO was also the organizer of a number of public lectures and debates on current topics related to the integration processes (“France/Croatia: Partnership for European Integrations”, “Croatia and EU: Lunch/breakfast Debate”). The practice of organising IMO forums on topics related to the position of the Republic of Croatia and its opportunities in an international environment and the cooperation with various research networks, such as TEPSA from Brussels and the Partnership for Peace Consortium from Germany, has continued.

In 2010 we made significant changes in the internal organisation and the methods of work which have enabled systematic support to research teams, innovation and flexibility in their work. By joining our efforts at four strategic workshops we have formed the basis for defining the Strategy of IMO’s Development in the period from 2011 to 2016.

IMO's Mission

To acquire, transfer and develop exceptional knowledge related to contemporary international economic, political and cultural relations, as well as current global, national and regional development processes of interest for the Republic of Croatia

IMO's Vision

To become a European research institution of excellence in the field of international relations and sustainable development

In conclusion, despite the global crisis, in 2010 IMO has made significant steps forward and confirmed to be a good partner in the international scientific community. IMO's knowledge and skills are contributing to the development of the Croatian accession towards the European Union. We have agreed that in 2011 we would work together to achieve the vision of IMO's further improvement in the quality of scientific research and the transfer of knowledge by investing in our human resources and strengthening our organisational development.

We do not consider the investment in public recognition of IMO, the recognition of research beneficiaries and the transfer of knowledge less important and we expect this 2010 Annual Report to contribute to the perception of IMO as an excellent scientific and research institution in the field of international relations and sustainable development.

2. General information

The **Institute for International Relations (IMO)** was founded by the University of Zagreb and the Croatian Chamber of Commerce in 1963 as the Africa Research Institute.

The Institute changed its name in 1971 to the Institute for Developing Countries and its research expanded to all developing countries.

In 1989 the Institute changed its name again, now to the Institute for Development and International Relations (IRMO) expanding its activities to international economic and political relations, European integration processes, transitional economies and competitiveness, cultural policies and cultural industries and environmental protection and sustainable development.

In 1996 the Institute changed its name to the Institute for International Relations (IMO), although the fields of research remained the same.

The activities of IMO are focussed on applied scientific and development research, the dissemination of research results, the achievement of scientific competence and offering scientific basis for the activities of the Government of the Republic of Croatia and its ministries, as well as other state bodies and organisations.

Basic fields of expertise are:

- International economic and political relations
- European integrations
- Regional development
- Sustainable development and environmental protection
- Energy policy and climate changes
- Competitiveness and development of entrepreneurship and clusters
- Cultural and media policies and international cooperation and communication
- Specific aspects of security in the international environment.

The research activity of IMO is achieved through scientific projects and collaborative scientific programmes, as well as through market projects.

2.1. Management Council

The Management Council of IMO manages financial and business policies of the Institute; adopts the financial budget of the Institute on the proposal of the Scientific Council and upon the approval of the Minister; makes decisions related to annual

accounts; decides on the establishment of organisational units of the Institute with the approval of the Ministry; makes individual decisions regarding employment as a body of the second degree; and gives the founder, the Director and the Scientific Council proposals and opinions on certain issues.

The Management Council of IMO consists of five members, one of whom serves as the President of the Management Council. Three members, including the President of the Management Council, are appointed by the Minister. The Scientific Council of IMO elects one member, and one member is nominated by the employees of IMO by direct and secret ballot, in accordance with the Law on Labour and the Statute. The mandate of the Management Council lasts two years.

The members of the current Management Council whose mandate began in November 2010 are:

Six meetings were held by the Management Council in 2010. Four meetings were held by former members (Mladen Andrić, Ph.D., president of the Management Council and members, Profesor Olga Carević, Ph.D., Marin Mihanović, Ph.D., Ana-Maria Boromisa, Ph.D. and Mira Mileusnić Škrtić, M.S.), and two by new members. In accordance with the decision on appointing the president and members of the Management Council of the Institute for International Relations of 21 October 2010, the members of the Council for another term were appointed: Mladen Andrić, Ph.D., as President and Prof. Olga Carević, Ph.D., and Mr. Staša Skenžić, prof. as members. The mandate was also extended in November 2010 to Ana-Maria Boromisa, Ph.D., the representative of the Scientific Council to the Management Council and to Mira Mileusnić Škrtić, M.S., the representative of employees to the Management Council. At the meetings the members discussed and made decisions about the financial budget of IMO and its execution, financial plan, financial reports for the defined periods, internal regulations, the IMO's work programme and its implementation and on other matters stipulated by the Statute.

2.2. Scientific Council

The Scientific Council establishes and implements the scientific policy of IMO, discusses and decides on scientific and expert issues, carries out the procedures for the selection to scientific, associate and professional positions, appoints and dismisses one member of the Management Council of IMO; recommends candidates for the committee for the election of IMO's Director and proposes the budget of the Institute to the Management Council. The Scientific Council discusses and gives a preliminary opinion on the decision of enacting the Statute and general acts issued by the Director.

The Scientific Council passes decisions, upon agreement of the majority of all members, at its meetings. Members of the Scientific Council are researchers, associates elected to the positions of senior assistants and representatives of junior researchers (one representative for every 5 junior researchers) elected by junior researchers employed at IMO.

During 2010 the Scientific Council has had 10 meetings. All meetings were held under the mandate of Daniela Angelina Jelinčić, Ph.D., President of the Scientific Council. Eight regular meetings and two special meetings were held at which issues were discussed and decisions were made in accordance with the law and Statute related to IMO's programme of work and reports on the work of junior researchers, the proposed budget of the Institute, on the election to the scientific profession and the election to scientific and professional jobs, proposals for new research projects, reports on the research results achieved within the scope of individual projects, participation in international and national conferences, seminars and workshops, as well as other matters stipulated by the Statute.

2.3. Director

The Director of IMO is Mrs. Sanja Tišma, Ph.D., research advisor, who was appointed by the Management Council of the Institute on June 6, 2009 for a period of four years. The Director organizes and manages the work and activities of IMO, represents the Institute, carries out all legal actions on behalf of the Institute, carries out the decisions of the Management Council and Scientific Council of the Institute and is responsible for the legality of work. The Director enacts all general acts of the Institute with the approval of the Management Council, except the Statute, and is responsible for their implementation. In addition, the Director submits to the Management Council a report on the annual and periodic accounts and proposes to the Management Council and the Scientific Council to make decisions on certain matters within their jurisdiction, and decides on the hiring and termination of employment.

The Department for International Economic and Political Relations is engaged in the research related to international determinants of competitiveness (MSES's project: "International Aspects of Competitiveness; Restructuring and Entrepreneurship" senior researcher Nevenka Čučković, Ph.D.) and economic aspects of security (MSES's project: "Economic Aspects of Security" senior researcher Mladen Staničić, Ph.D.). New topics are gradually introduced into the research, such as the role of the international community in building a democratic state after internal conflicts, as well as challenges to the peace in the world set forth after political and religious radicalism. The introduction of new topics and cooperation with other IMO's departments and other researchers enables the expanded scope of our work and contributes to the mission through the development of new knowledge.

The Department for European Integration is devoted to interdisciplinary scientific research focused on the economic, legal and political development of the European Union and its relations with candidate and non-member countries. Internal reforms

within the EU, the enlargement process, and relations with South-Eastern Europe, including the accession negotiations between Croatia and the EU, are at the centre of research interests. In addition to scientific research, the Department's activities include the development of an information infrastructure and education in the field of European Studies. The Department closely cooperates with the „EU i“- **Documentation Centre** and helps in promoting its activities, as well as facilitating a continuous flow of information through the EnterEurope web portal. In 2010 the Department for European Integration continued to implement the MSES's project „Lisbon Strategy - Reform Catalyst in the EU and Croatia“ (senior researcher Višnja Samardžija, Ph.D.). The Department for Culture and Communication is engaged in interdisciplinary scientific research in the field of cultural development, cultural and media policies, international cultural cooperation and communication. Primary research areas include cultural diversity, intercultural communication, digital culture and networks, creative industries and cultural tourism, cultural changes (cultural integration and disintegration), and the process of globalisation and transition. Mediatisation of culture, the character of the media environment, the dynamic development of media and their social and civilisation functions are also the focus of the research of the Department. The Department investigates the changes of Croatian cultural identities which take place in the global and the European environment. The main areas of activity of the Department include: scientific and applied research, scientific publishing, educational activities, conferences and seminars, development of web resources to support research and cultural cooperation. The Department co-ordinates the activities of the Culturelink network, international network for research and cooperation in the field of cultural development. In 2010 the Department continued to implement two MSES's projects "Global Influences and the Local Cultural Changes" (senior researcher Nada Švob-Đokić, Ph.D.) and "Cultural Diversity, Intercultural Communication and Digital Culture" (senior researcher Daniela Angelina Jelinčić, Ph.D.). The Department for Resource Economics, Environmental Protection and Regional Development is devoted to interdisciplinary scientific research and analysis in the field of sustainable development, environmental protection, regional and local development and policy as well as good governance. Particular focus is given to planning, implementing and monitoring of economic, social and environmental policies to support local, regional and national development. The research focuses on defining

public policies and public participation, especially in the field of environmental and nature protection, climate changes, regional development and public administration reform in relevant sectors. In 2010 the Department continued to implement the MSES's project "Management of Natural and Human Resources – Regional Development and Environmental Protection" (senior researcher Sanja Tišma, Ph.D.).

„EU i“ Documentation Centre was established by the European Commission in IMO's premises and it serves as a support to the research of the European integration process and Croatian accession process. The "EU i" Documentation Centre regularly receives official documentation, publications and other information material from European institutions, and maintains and upgrades EnterEurope portal (www.entereurope.hr) and submits annual reports to EU Delegation in Zagreb.

The Project Support Centre provides necessary information, organisation and expert assistance to IMO's research projects, especially in the application and implementation of international projects (such as FP7 - LEAR, WB, UNDP, EC and other international institutions and funds). Main activities of the Centre are focused on the application to international projects, necessary tender documentation is ensured and IMO's list of references is reviewed updated. The Centre participates in analytical and statistical processing of research results and develops computer-information infrastructure.

3.2. Supporting services

The Secretariat performs legal work in the field of IMO's activities (administrative, property and legal issues in the field of labour relations). It follows legal regulations in the field of IMO's activities, prepares sessions of IMO's bodies (Scientific Council, Management Council, commissions), defines contracts with project clients and associates, develops drafts of general acts, decisions and solutions, provides legal advice in the fields of IMO's activities, organises administrative, technical and office activities and the implementation of technical and supportive work, maintenance of premises and facilities, as well as the activities related to protection at work.

Accounting Office performs the overall financial operations of IMO and prepares financial reports in accordance with applicable regulations and business needs of the Institute; prepares accounting records and records of salaries, sick leaves, honorariums and all other payments; performs payments of all obligations to the state and other

creditors; keeps records of customers and suppliers, cash register (in kunas and other currencies); keeps a book of revenues and expenditures classified by projects and types; prepares financial plans, including investment, maintenance and procurement plans, and performs operational preparation of the financial part of the projects' work plans. Furthermore, the Accounting Office provides necessary data for the assessment and evaluation of performance.

Library and Documentation procures, processes, stores and lends books, documentary material, journals and newspapers, exchanges publications of the Institute with similar institutions at national and international level; follows the publishing industry in the field of scientific research activities of the Institute for a systematic procurement of literature, follows progress in the librarian profession and applies it in practice; collects, processes and keeps special types of documents of the Institute and other institutions; searches bibliographic databases, reviews and information of contemporary national and international sources necessary for research activities of the Institute; cooperates in editorial preparation, distribution and promotion of IMO's publications, and organizes and conducts archives of the Institute in accordance with applicable regulations.

4. Employees

IMO currently employs 41 employees, from which 31 (75%) are researchers (scientists, junior researchers and professional associates in science) and 10 (25%) are employees in professional services (administration, secretariat, library, finance and accounting) and technical staff (delivery, protection at work and maintenance).

In IMO work posts are defined according to the Regulation on the structure of work posts, dated February 19, 2010, to which the MSES gave its approval on March 12, 2010, and according to amendments to the Regulation of July 13, 2010, to which the MSES gave its approval on July 19, 2010. All work posts are occupied. Over the past few years IMO has had the need for more junior researchers and had employed them for a certain period of time according to the approved new work posts by the MSES. In 2010 IMO did not employ any new researchers or junior researchers.

5. Equipment, facilities and working material

The office of the Institute for International Relations is located in the building of the Croatian Forestry Association, Ljudevita Farkaša Vukotinovića 2 in Zagreb. Business premises are leased and are located on the second floor of the building, occupying an area of 689.08 m² on two floors. The lack of own appropriate (at least 300 m² bigger) office space is a major problem and source of uncertainty in doing business.

IMO has modern IT and office equipment with software work bases. Hardware and software computer maintenance is performed by Comwear, Ltd., while Libusfot Ltd. maintains the database in the accounting office.

In 2010 IMO acquired four desktop computers, two notebooks and two laser printers. The Institute's domain has been registered for two years. IMO uses licensed Microsoft software purchased through SRCE, and the licensing and updating of anti-spam protection has been extended. The license for Sophos anti-virus protection has also been extended.

6. Programmes and projects of continuous scientific research activity

Since 2007 scientific research activity in IMO has been conducted in the scope of two programmes and six research topics.

PROGRAM: International Aspects of Knowledge Based Society - Integrations, Security, Economy and Environment

Within the scope of this programme the researchers analyse various aspects of international economic relations, the current political processes and the position of Croatia. The regional dimensions of Croatian economic and political position in the international community, Croatian strategic policy and relations with international integration, privatisation and post-privatisation aspects of the Croatian economic transformation, as well as the position of Croatia in international trade and financial relations are examined.

In the scope of this scientific programme the research has been conducted within four long-term projects funded by the MSES since 2007:

The project conducts the research on the economic aspects of security. During the first two years of the project the focus was placed on issues related to NATO, the main security organisation in the world, on NATO's role in establishing political stability and economic security in Southeast Europe and NATO's role in strengthening energy security. In the third and fourth years the focus has been on other topics, as well as NATO. The researchers analyzed relevant aspects of joining the EU and the estimated impact of other global and regional organisations (UN, WTO, the Energy Community and the Regional Cooperation Council) and some states (notably the USA and Russia)

on economic security and crisis management.

In 2010 special attention was paid to the new NATO strategy paper (Strategic Concept for the Defence and Security of the Members of the North Atlantic Treaty Organisation) which was adopted in Lisbon (November 2010). In addition to numerous articles and reviews on the text of the document in preparation and to its final version, within the scope of this project IMO organized two international conferences. The first, with special emphasis on the role of new member countries of NATO (NATO's New Strategic Concept: A Perspective from the new member states) was organized in May, with the support of NATO Public Diplomacy Division and the Ministry of Foreign Affairs and European Integration. The second was organized in December, immediately after the adoption of this document (NATO's New Strategic Concept: Challenges and Perspectives) with support from the U.S. Embassy in Croatia and the NATO Public Diplomacy Division. All materials from these conferences are published in the scientific journal of the Institute for International Relations (Croatian International Relations Review) and thus have become accessible to a wider readership.

The main sections of the project were the following analyses: "Costs and benefits of Croatian accession to NATO", "New strategic concept of NATO", "Safeguarding the security of the Adriatic Sea", "Assessment of regional security threats and challenges in the Western Balkans – the case of Croatia", "Energy Security" "Increasing the capacity of civil society for measurement and monitoring of Security Sector Reform in the Western Balkans", "Analysis of the Common Foreign and Security Policy and its impact in South East Europe" and "Analysis of Security Transition of South East Europe - from consumers of security to the zone of stability". Smaller project units are defined in accordance with the plan and the research protocol. They enable a systematic analysis of the economic aspects of security, and include an analysis of reforms within the EU and candidate countries, assessing the impact of the UN, WTO, the Energy Community and the Regional Cooperation Council on economic security.

Main results were presented at conferences and were published in journals and books. The project's associates participate in university teaching and in the activities of other scientific institutes (Ivo Pilar Institute, Institute for Public Finance) and working bodies of local institutions (e.g. National Foundation for Civil Society Development, Ministry of Foreign Affairs and European Integration).

In the scope of the project "Enhancing the capacity of civil society for measurement and monitoring of Security Sector Reform in the Western Balkans" IMO researchers fully cooperate with partners from the region at workshops (Budva, Mavrovo, Durres, Zagreb, Priština, Kolasin) and conferences (Sarajevo), which enables a comparative analysis of regional security issues and various aspects of EU integration and the related reforms in South-eastern Europe. Regarding reforms to access the EU, the researchers have studied issues relating to the exercise of organized political and

economic interests in the EU and the countries of Southeast Europe, cooperation on security issues in Central Europe and the importance and effectiveness of technical and financial assistance to reforms. The results of the whole project related to the EU were presented at several national and international conferences and seminars (Zagreb, Budapest, Tuhelj, Ohrid, Dijon, Warsaw, Vienna, Osaka, Kyoto, and Tokyo).

The results of the section on the role of the UN, its bodies, agencies and conventions (UNDP, UNECE, UNFCCC, the Security Council) on economic security, including elements of energy security and environmental safety have been published in several papers. Wider dissemination of knowledge is ensured through participation in the educational program of the UN academy launched by IMO and the Croatian Society of the United Nations.

The importance of membership in WTO, including its relationship with economic security, was presented at the regional workshop of the WTO in Geneva.

The results of research on energy security in South-eastern Europe, which identifies the connection between investment in infrastructure and the possibilities of strengthening the region's geopolitical importance, were followed up by the analysis of the impact of the Energy Community and the Council for Regional Cooperation on reforms in South East Europe and the possibilities of integration to the EU. The focus was on opportunities to finance sustainable solutions for improving energy efficiency, the analysis of relations in Southeast Europe and the possibilities of cooperation. It was determined that energy efficiency and regional cooperation have significant potential for increasing energy security (smaller negative impact on the environment, the greater security of supply, cost reduction), and that these elements are the key to reducing the economic dependence and creating opportunities to enhance self-sufficiency, without compromising allocative efficiency. The results were presented at several international conferences (Dubrovnik, Berlin, Paris) and national workshops (Zagreb, Split, Rijeka and Osijek).

In cooperation with partners from Japan bilateral Japan-Croatia conferences have been held regularly since 2004. The success of the cooperation is evident by the fact that in 2010 a regular conference was held in IMO and one of the researchers of this project, at the invitation of partners from Japan, held a series of lectures in front of various experts and students at several Japanese universities (Osaka, Kyoto, Doshisha, Tokyo), presenting the results of research in the past few years. The cooperation with partners from Hungary (Institute for World Economics, Hungarian Academy of Sciences) has intensified and the first Hungarian-Croatian bilateral workshop was held.

The successful cooperation with renowned European institutions dealing with issues of international relations and security (DCAF, EU Institute for Security Studies, TEPSA, Partnership for Peace Consortium and Consortium of Defence Academies) has continued in this period.

017-0171682-1288 “International Aspects of Competitiveness; Restructuring and Entrepreneurship“, senior researcher: Nevenka Čučković, Ph.D.

Planned activities and objectives of the project continued to be implemented in 2010, in accordance with the phases of the project plan and the research protocol through several national and international empirical studies of basic international guidelines and problems of Croatian competitiveness and entrepreneurship. In addition to theoretical and methodological contributions, the research contained the component of applicability for the guidance of economic policies and efficiency in educational activities. Intensive international cooperation is an integral component of our work through participation in various international research projects, networks, international conferences, and dissemination of research results through publications, seminars and lectures at home and abroad, as well as through the project's web portal.

In March 2010 the new one-year research project was initiated in cooperation with the London School of Economics “Privatisation of public sector services in Croatia and SEE” (N. Čučković, Team leader) which has the intention to evaluate the basic economic and other effects of the privatisation process of public sector enterprises and in particular in terms of their impact in the improvement of business efficiency, quality of services, quality management, price trends, consumer welfare, the size of capital investment and employment. For the sample of two public companies that are largely or partly privatized in Croatia (HT and INA), the project will offer an analysis of key economic and social impacts of privatisation in comparison with two selected groups of countries: a) new EU member states and b) selected countries of Southeast Europe which had privatized telecommunications and the petroleum industry. During 2010 we participated with two papers on research conferences in London and Brussels organized by the London School of Economics (LSE) and the Institut Francais des Relations Internationales (IFRI), Paris.

After the completion of the four-year FP6 project “EU-Consent” (2005-2009), the researchers have continued to collaborate on some project components that ensure the financial viability for the next two years. With financial support of IEP, Berlin and CIFE, Nice the publishing of the electronic journal “EU-27 Watch” was renewed in July 2010 when issue number 9 was published. In this issue our report on Croatia analyses the policy of EU enlargement towards the Western Balkans, the remaining conditions and criteria for the closure of negotiations for full membership of Croatia, the impact of the economic and financial crisis in Greece to the EU stability and the spill over effects on Croatia, the importance of the Europe 2020 Strategy; EU energy policy and the adjustment of Croatia, fight against corruption, improvement of relations with the neighbours in the region, etc. All previous issues are available at www.eu-27watch.org and IMO is the only partner from Croatia.

In the scope of long-term cooperation with the National Competitiveness Council (NCC)

the research on factors and results of the competitiveness of the Croatian economy, according to the standard WEF indicators (K. Jurlin, Team leader) continued in 2010. Targeted research was carried out and summary reports and analysis of the results of Global Competitiveness Report 2009/2010 of WEF and IMD year book were prepared with a focus on reasons for changes in the position of Croatia. A statistical analysis of indicators for Croatia was conducted as an input to the IMD World Competitiveness Yearbook. In the scope of activities of the NCC and for the purpose of developing the document "Charter for the new development" the revision of the definition of key indicators and analysis of the feasibility of development of simulated projections were implemented. Analyses are available on www.konkurentnost.hr.

In 2010 other research on Croatian regional competitiveness "Analysis of Croatian Regional Competitiveness Index 2010" (K. Jurlin, Team leader) supported by UNDP and in cooperation with the Faculty of Economics in Osijek was realised. This is a continuation of the research of the Regional Competitiveness Index 2007 which was prepared for the UNDP in cooperation with SENSE Consulting. The project consisted of defining and testing indicators of competitiveness, their grouping into factors of competitiveness and development and final indices, which rank counties and regions according to their competitiveness. In the scope of the study, a large executive survey was conducted and analyzed, whose answers are used as indicators of certain aspects of regional competitiveness. The benefit of this research is to (inter alia) use the prepared database in development and evaluation of development strategies of the Croatian counties.

For the purpose of analyzing the competitiveness of selected counties (Vukovar-Srijem County, Osijek-Baranja County, The County of Zagreb and the City of Zagreb), analytical papers on economic development were prepared (K. Jurlin). Numerous key indicators of economic development were analyzed and benchmarking was used - indicator values of each county were compared with Croatian average to identify their strengths and weaknesses. The trends of economic growth, restructuring and employment were analyzed and industry sector, services and agriculture analyses carried out.

In 2010 the team participated for the third time in the research of OECD and EC, which evaluates the achievements of policy development of SME (small and medium enterprises) in the "SME Policy Index for Croatia" which, based on some hundred indicators and benchmarks, follows the adjustability of the entrepreneurial environment in Croatia to the new EU Law on Small Entrepreneurship (2008). The client of the project is the Ministry of Economy, Labour and Entrepreneurship, which, in addition to IMO's researchers, gathered a team of around 30 local experts and institutional stakeholders.

Within the scope of the IMO Forum, the discussion on "Russia: Yesterday, Today and Tomorrow" was organised, which analyzed the importance and role of the Russian

Federation in international political and economic relations, and the impact on relations with Croatia (S. Šelo Šabić, Chair) with an introductory presentation of former Croatian Ambassador to Russia, Mr. Božo Kovačević.

The project collaborators, including junior researchers, teach at undergraduate and postgraduate studies at the Faculty of Economics, College of International Relations and Diplomacy, and the Faculty of Political Science. In 2010 Team leader N. Čučković continued her active participation as a member of the Croatian delegation to the FP7 Programme Council for Socio-Economic Sciences at the European Commission in Brussels.

017-0171682-1286 “Lisbon Strategy - Reform Catalyst in the EU and Croatia“, senior researcher: Višnja Samardžija, Ph.D.

Within the scope of the scientific research project in 2010 the implementation of the research continued in accordance with the project protocol within three project sections: (1) the conceptual and implementation issues of the Lisbon Strategy (LS) in the enlarged EU and preparations for Europe 2020, (2) convergence of the objectives in the context of negotiations on Croatian accession and the progress of countries in the region of Southeast Europe, (3) the role of interest groups and civil society organisations in the European integration process.

As the result of the work on the project in 2010 the researchers have published a book with contributions from several authors, 2 scientific papers in other journals, 6 other papers in other journals (views, reviews), and 2 reports in the Book of abstracts of international conferences.

Since 2010 marked the completion of the implementation of the Lisbon strategy and the development of the new strategy Europe 2020, the research on the project was mainly focused on evaluating the achievements of the Lisbon Strategy in the EU and Croatia during the past decade in various fields (science and research, education, competitiveness, market competition, social welfare, social economy, energy, environmental protection) and a preliminary analysis of the possible contribution of the new strategy Europe 2020. The research team which participated in this research was expanded by the MSES to other IMO's scientists and colleagues from Croatia and abroad. The result was the book “From Lisbon Strategy to Europe 2020” which was published with the support of the Delegation of the European Union in Croatia (editors V. Samardžija and H. Butković). Thus the previous research on the analysis of the Lisbon strategy was encompassed and a new area of research focusing on Europe 2020 opened up. The main findings of the book were presented at the international conference “From the Lisbon Strategy to Europe 2020” held in Zagreb in December 2010.

In 2010 other areas of research were related to traditional and innovative aspects

of the democratic practices of the political system of the EU. The broader context of Croatian accession to the European Union was analyzed, as well as specific aspects of business establishment and market competition. Furthermore, research was focused on evaluating opportunities to enhance regional cooperation in Southeast Europe in the context of economic crisis (participation at IMO round table in cooperation with the University of Osaka, the paper was published in the Book of abstracts in Japan). Researchers have also contributed to the analysis of the development of Southeast Europe as the knowledge-based society. The results of analysis focused on “knowledge triangle” (research, education and innovation) were presented to the conference at the Robert Schuman Centre of European University Institute EUI, Montecatini Terme, Italy and published in the book “The Western Balkans’s Accession to the European Union”.

Researchers have intensified their cooperation within the TEPSA network (the Trans European Policy Studies Association) in Brussels. V. Samardžija is a member of the Management Board and has participated at two conferences on the eve of the new presidency of the EU Council (Madrid, Budapest). Furthermore, researchers are involved in the negotiations on Croatia’s membership in EU and participate in evaluations of the National Foundation for Civil Society Development.

Teaching engagement at the institutions of higher education continued in the field of European Studies at the Faculty of Political Science, University of Zagreb and the University Josip Juraj Strossmayer in Osijek.

017-0171682-0891 “Management of Natural and Human Resources – Regional Development and Environmental Protection“, senior researcher: Sanja Tišma, Ph.D.

The research on the interaction of economic, social and ecological systems from the perspective of sustainable management of natural and human resources development at regional and local level continued in 2010.

Studies were implemented within the scope of 4 sub-themes: (1) Measurement of local and regional development and evaluation of development strategies, programmes and projects, (2) Economic evaluation of natural resources as a contribution to their sustainable economic use, (3) Data collection and analysis of financing environmental protection – with additional analysis of the availability of the information on collection and disposal of hazardous wastes, and (4) energy efficiency - an incentive for the ESCO project in local and regional self-administration units.

Based on the analysis and results of research projects from the past few years, the methodology for calculating development index was prepared and the ranking of sustainable development in all cities, municipalities and counties in the Republic of Croatia was implemented. Furthermore, researchers are actively involved in developing methodologies for evaluating the planning and implementation of European

programmes and projects in Croatia. The methodology was tested on two separate occasions (i) with the potential beneficiaries of EU funds and (ii) with end users, and the findings will be presented at an international conference in 2011.

The data collected and processed for the monitoring of regional development has been used as analytical bases for evaluating investments in the system of nature protection in Croatia. The projections of possible growth in population welfare near protected areas (national parks and nature parks) were prepared based on their sustainable use in the future. Studies of the nature protection system included a comparative analysis of financing of nature protection in several European countries and in the Republic of Croatia and recommendations for long-term sustainable use and economic financing of the system in Croatia were prepared. In doing so, a new area of research in IMO was opened in relation to rural development and its connection with protected areas management for which there are sectoral analysis in Croatia, but there is no interdisciplinary approach to the development of the topic. The findings of this research were used as a basis for preparing applications for European funds.

One of the topics initiated in 2009 is the analysis of European directives in the field of hazardous waste and the preparation of analytical materials and models for continuous monitoring and sustainable management in the future. Basic research findings on types and quantities of hazardous waste (survey on a sample of 600 companies - potential producers of hazardous waste) pointed out shortcomings in monitoring and collecting of produced quantities and the lack of information on the disposal / storage of most hazardous waste. The findings and recommendations of the research will provide decision-makers in preparing a new system (strategy) of hazardous waste management in Croatia.

The research related to energy efficiency, particularly on the possibilities of the use of the ESCO model as an enabling model for financing institutions in the energy efficiency of local and regional self-government units, have continued

In the scope of the project the cooperation with the London School of Economics was established in 2010 through organizing an international conference "Regional Development and Decentralisation in South East Europe", and through the preparation and implementation of the research project "Political Economy of Decentralisation and Regionalisation in South East Europe: the socio-economic impact," which continues in 2011. An important area of decentralisation was discussed in a scientific paper "Challenges of a new approach to management of development at local and regional level in Croatia", presented at a scientific symposium of the Croatian Academy of Sciences and Arts on regional and local self-administration, which resulted in the inclusion of the members of the Department to the Government's working group on territorial decentralisation of the Republic of Croatia. Scientific contribution to this field was presented in a scientific paper: "The new role of local and regional actors

in supporting development in Croatia” presented at the annual international scientific conference of Regional Science Association in Pécs.

The research continued and improvements were achieved in the methodological contribution to the strategic planning and management at regional and local level in Croatia, especially by linking strategic planning with budget planning. Within the scope of the project, support was provided for the systematic development of five county development strategies and five ex-ante evaluations of county development strategies. The international research cooperation continued during 2010 through the project “Natural zeolites in nanotechnology of waters”, which is implemented by many renowned institutes and universities from several European countries.

The involvement of researchers as lecturers at the postgraduate study “Economics of the European Union” at the Faculty of Economics, University of Zagreb, the International Graduate Business School (Indiana University) in Zagreb, at the Faculty of Law in Zagreb and at the Diplomatic Academy of the Ministry of Foreign Affairs and European Integration continued. Moreover, a special program on preparation and implementation of projects for EU funds was designed in cooperation with Business Academy Experta.

Two junior researchers regularly attend and fulfil their commitments in the scope of doctoral studies at the Faculty of Political Science and the Faculty of Economy.

PROGRAMME: Promotion of Cultural Identities and the Process of Croatian Integration into EU

Within the scope of the scientific programme „Promotion of Cultural Identities and the Process of Croatian Integration into the EU”, the research of the Department for culture and communications has been conducted in the scope of two long-term projects financed by the MSES since 2007:

- Global Influences and the Local Cultural Changes, senior researcher: Nada Švob-Đokić, Ph.D.
- Cultural Diversity, Intercultural Communication and Digital Culture, senior researcher: Daniela Angelina Jelinčić, Ph.D.

Two projects within the scope of this programme are implemented at the Faculty of Philosophy in Rijeka and Zagreb:

- (Post)transitional Discourse: Representation, Simulation and Identification, senior researcher: Marina Biti, Ph.D., Faculty of Philosophy, University of Rijeka
- Nation and Representation, senior researcher: Vladimir Biti, Ph.D., Faculty of Philosophy, University of Rijeka

The programme combines the basic assumptions that in the transition and post-transitional period, Croatian culture and Croatian cultural identities are rapidly reconstructing and tend to integrate into the European cultural space. The process of reconstruction and integration of cultural identities is questioned from different perspectives: from internal dynamic disintegrations and recreating representative symbolic values, to the acceptance of cultural diversity as a basis for cultural affirmation, development and integration. Based on these assumptions, the line of research includes inquiry into historical perspective, the emergence and (transitional) deconstruction of Croatian cultural identity, recognition of identity of others and integration into the European cultural space.

017-0171685-1490 “Cultural Diversity, Intercultural Communication and Digital Culture”, senior researcher: Daniela Angelina Jelinčić, Ph.D.

Cultural diversity, intercultural communication and the rapid development of digital culture are resources leading towards knowledge societies. The goal of the project is to prove this hypothesis by researching the different characteristics of their interconnection / interrelation.

The work on the project in 2010 was focused on research of cultural diversity and intercultural dialogue in Croatia in terms of daily coexistence with other cultures, as well as in interim contacts with tourists. The research conducted for this purpose, initiated in 2009, was implemented in the entire Croatian territory, and the findings were grouped into three main themes: the key points of their own identity; existing stereotypes of foreigners and the minority in Croatia (and tolerance towards them); and the level of contact with other cultures. The results show a relatively high degree of stereotyping of “Others” and a relatively good knowledge of their own, mainly local culture and heritage. Highlighting “Self” in front of “Others” is present in a high percentage. Tourism is considered a positive way to learn about “Others” and it is the opportunity for different forms of communication, mobility and migration that create different ways of connecting, sharing and cooperation, and intercultural communication (but mostly superficial intercultural dialogue because of contact transition). The findings are published in the book “Culture, tourism, interculturalism” prepared by three authors. The book also makes recommendations for cultural, touristic, educational and scientific policies and strategies for Croatia in the field of cultural diversity and intercultural communication / dialogue.

The role of culture in the economy was also observed which is partly achieved through cultural tourism, cultural industries and cultural entrepreneurship, which are based on cultural diversity. The work on the project in this area has resulted in a published book “Kultura u izlogu” (Culture in the shop window) and a study “Zagreb kao kulturni proizvod” (Zagreb as a cultural product). The first provides a theoretical knowledge in

this area, and the other focuses on local differences and explores their potential in the international recognition of the city in the field of culture and the tourist attraction.

In the scope of the project an agreement with the European Parliament called "External Expertise Services relating to Culture and Education Policies" was also signed for an independent expert consulting re the issues which the European Parliament has in the field of culture and cultural policy. The first project under that agreement concerns the question of private investment in culture. Furthermore, the project "European Expert Network on Culture (EENC)" of the European Commission was awarded to IMO to provide expert services in the field of cultural policy research.

In the aspects of digital culture the challenges that new technology sets to the field of culture and the role of cultural portals in the context of digital cultural convergence were analyzed in 2010.

All these topics were elaborated in two books, published book chapters, scientific papers in journals and conference proceedings.

In addition, the Strategy of the Development of Museum Activities in Dubrovnik Museums Dubrovnik was developed, as well as the first stage of Cultural Strategy Development for the City of Dubrovnik. Both projects rely on the topic of cultural diversity which is expressed in practice since Dubrovnik is the tourist destination and issues relating to the change of local identity and achieving intercultural communication / dialogue, as well as the promotion of cultural diversity can be seen through the encounter of different cultures.

The results of the research were presented at numerous conferences in Croatia and at international conferences (U.S.A., Hungary, Spain, Montenegro, Greece, Belgium, Serbia, Netherlands, Korea, Luxembourg), and the knowledge gained through the project are regularly used in teaching at the University of Dubrovnik and Zadar, in the course "Management of cultural goods", "Cultural economy", "Cultural diversity and the mass media" and "Cultural heritage and tourism development".

A part of systematized results of the project was published in previously published book "Abeceda kulturnog turizma" (The alphabet of cultural tourism) which was in 2010 awarded by the City of Zagreb Award.

Junior researchers regularly attend and fulfil their obligations within the scope of the doctoral study "Comparative Politics" at the Faculty of Political Sciences in Zagreb. Some project collaborators are members of certain bodies in international networks (Culturemondo, LabforCulture, ELIAMEP), and in 2010 one was promoted to senior research associate.

017-0171685-0806 "Global Influences and the Local Cultural Changes", senior researcher: Nada Švob-Đokić, Ph.D.

The content and objectives of the project are focused on monitoring and review

of the global impact on local cultural changes, i.e. on the processes of interaction between global and local cultural developments. The issue of cultural globalisation and elements of local cultural development are questioned through theoretical aspects. Survey methods enabled the analysis of the development of cultural / creative industries and cultural entrepreneurship in the cities and / or at subregional levels (in all Croatian regions), the analysis of consequent changes in cultural identification, the international cultural communication and mediatization of culture, and changes in the overall cultural and media environment. The results obtained through interviews with cultural workers and artists (in 2007 and 2009) were discussed in the focus group discussions.

Basic aims of this research were successfully achieved and they include the analysis of cultural development in Croatia, which is formed through interaction with global cultural trends (cultural niche), analysis of re-structuring of cultural identities, and the analysis of cultural communication and cultural integration into the European and global cultural space.

The research team consists of two young researchers and one research advisor who cooperated with a number of colleagues from Greece, Macedonia, Serbia, Slovenia, Austria, Hungary, Great Britain, Spain, Germany, Bulgaria, Slovakia, Estonia, Turkey, Finland, Denmark, Italy and Japan.

Publication of research results within the scope of this project include four monographs, one book of abstracts, 19 book chapters, 13 scientific papers and 17 lectures and scientific papers published in conference proceedings, as well as multiple reviews and other types of papers published on-line. Apart from the number of published papers, two monographs should especially be noted because they best reflect the multi-year research on the project. The book "Kultura zaborava. Industrijalizacija kulturnih djelatnosti" (Culture oblivion. Industrialisation of cultural activities) (2008) by Švob-Djokic, Primorac and Jurlin, published by Jesenski i Turk and Croatian Sociological Society, Zagreb, for the first time systematically analyses the cultural processes of industrialisation in Southeast Europe. The book "Kultura/multikultura" (Culture/multiculture) (2010) published by Jesenski i Turk and Croatian Sociological Society, Zagreb, includes works by N. Švob-Đjokić, J., Primorac, P. Bilić, J. Dorotić and K. Jurlin which analyze in detail global and European environment for the development of Croatian culture and indicate the ways of adaptation and integration of local and global cultural trends.

International cooperation provides important expansion of research interest in the scope of this project and focuses on specific research tasks. Research has expanded through international research cooperation within the Council of Europe, the European Union and bilateral cooperation with the University of Osaka, in the framework of several interactive projects. The project of the Council of Europe "Compendium of Cultural

Policies and Trends” is achieved in cooperation with the Institute of Comparative Cultural Studies - ERICarts from Germany and a number of other European partners and is concentrated on an annual analytical report on Croatian cultural policy, and a series of specialized studies (e.g. ‘Contribution of Culture to Local and Regional Development as Part of European Cohesion Policy’, 2009). This project team is a partner with another 13 universities and research organisations in the three-year collaborative project of the EU’s Seventh Framework Programme (FP7) “European Media Policies Revisited: Valuing and Reclaiming Free and Independent Media in Contemporary Democratic Systems” - MEDIADDEM, which is coordinated by the Hellenic Foundation for European and Foreign Policy-ELIAMEP in Athens. International cooperation with the University of Osaka, Research Institute for World Languages, includes cooperation on the Croatian-Japanese seminars in Zagreb, participation in conferences in Osaka and joint publication of papers in the scope of the project “Lingua-Culture Contextual Studies in Ethnic Conflicts of the World” - LICCOSEC.

Regional cooperation is implemented throughout the project “Questioning transitional dynamics in re-defining cultural identities in South-eastern Europe”, which is carried out in cooperation with research institutes and universities from Slovenia, Austria, Serbia, Bosnia and Herzegovina, Montenegro and Macedonia.

Cooperation in Croatia is achieved with the Faculty of Philosophy, University of Rijeka, Faculty of Philosophy, University of Zagreb through networking of researchers in the scope of programme “Promotion of cultural identities and the process of Croatian integration into the EU”. In IMO, the members of the research project team work closely with “Cultural diversity, intercultural communication and digital culture” project team in the implementation of the projects “Connecting Croatia” and “Digital Culture: The Changing Dynamics”.

The participation in higher education programmes is achieved through the involvement in teaching activities at the Postgraduate doctoral study of sociology at the Faculty of Philosophy in Zagreb and graduate study of culturology at the Faculty of Philosophy in Rijeka.

The project “Global influences and the local cultural changes” achieves excellent results in research, publication and intensive international cooperation, through which it is recognized in European and extra-European scientific circles.

The focal point of world-wide network for research and cooperation in cultural development, **Culturelink**, is located in IMO. The network was jointly established by UNESCO and the Council of Europe in 1989 in Paris at the UNESCO Consultation of Representatives of Regional and Sub-regional Networks for Cultural Development Research and Cooperation. UNESCO and the Council of Europe proposed the Institute for International Relations in Zagreb to become the focal point of the network, citing the continued and successful cooperation with IMO and its international experience

in research, cultural development and international cultural cooperation. Culturelink Network now covers more than 1000 institutions in over one hundred countries on all continents, *Asia-Pacific Regional Centre of the Culturelink Network* in Korea (APRCCN). Activities of Culturelink network include international scientific research in the field of culture; the organisation of international conferences; regular publishing which includes Culturelink Joint Publication Series and monthly electronic newsletters C-News; the development of Culturelink WWW Resource Centre through which the information about new concepts, research challenges, trends, practices and experiences in the field of cultural policies, cultural management and development strategies are systematically collected and disseminated. In 2009 the Third World Culturelink Conference was attended by 130 participants from all continents. The event marked the 20th anniversary of the Culturelink Network. In 2010 the book "Networks - The Evolving Aspects of Culture in the 21st Century" was being prepared with the contributions of the conference participants, which will be issued at the beginning of 2011.

Summary: MEDIADDEM is a European research project aimed at understanding and analyzing the factors that promote or impede the development of policies supporting free and independent media. The project will combine the study of the media situation in individual countries with a comparative analysis of media sectors and types of media services. The process of formulating media policy in 14 European countries will be explored, starting from their socio-political, economic and cultural context. The project will examine the opportunities and challenges for achieving press freedom and media independence, which result from new media services. The external influences of the European Union and the Council of Europe in shaping national media policy will be analysed in detail.

The project objectives are the following: a) understand the character and functioning of media in today's complex media environment, b) understand the nature of media freedom and media independence, and their importance to democracy, c) explore how the media formulate and implement policies and identify factors involved in these processes; d) identify models of regulating the media that support media freedom and independence; e) link directly with the communities that formulate media policies and with civil society in order to create appropriate political (policy) responses to the challenges of achieving media freedom and media independence, f) develop specific recommendations to states and nonstate actors, the European Union and the Council of Europe for the implementation of media policies that strengthen media freedom and media independence.

IMO is one of the project partners. In 2010 the IMO team was working on establishing a theoretical basis for research and reviewing information about the Croatian media environment and regulatory system. The report "Media Policy in Croatia: the quest for free and independent media" was published and the contribution for the joint

project publication "Croatia: A Dynamic Evolvement of Media Policy" was written. The meeting of the MEDIADEM consortium was held, as well as the scientific workshop "Media Policies: Country Practices within the EU Regulatory Framework", which brought together over 40 participants from Croatia and abroad.

These are also currently two strategically important development issues for Croatia, especially considering the very considerable regional disparities in Croatia, and a strong need for decentralisation of management. The study, which will

be completed in 2011, will result in the proposal for the additional improvement of regional policies and the policy of decentralisation in Croatia and selected countries.

Summary: The goal of the Project was to analyze and prepare the investment plan to the amount of 20 million Euros in the Nature Protection Sector of the Republic of Croatia during the next 5 years to help expand and support Croatia's preparation for European Union (EU) accession. In the period from January to September 2010 analysis and assessments were made and 17 reports and proposals of activities prepared which should be funded from the NPIP project with estimated costs of planned investments. The findings and recommendations of all the components that are implemented through the project were discussed and updated at 13 round tables in the protected areas in Croatia, with about 300 participants. Furthermore, two presentations of project results were organized for the general public. Summary: One of the research topics that was initiated in 2009 was the analysis of European directives in the field of hazardous wastes and preparation of analytical materials and models for continuous monitoring and sustainable management in the future. In the scope of the project the researchers have prepared a methodology for analyzing the hazardous waste market in the Republic of Croatia, prepared and conducted a survey on a sample of 6000 companies on the quantities of hazardous waste produced by the economy and identify critical points related to hazardous waste at the county level, at the level of cities and municipalities. Basic research findings on the types and quantities of hazardous waste have pointed out the deficiencies in monitoring and collecting the quantities produced and the lack of information on the disposal/storage of most of hazardous waste. The findings and recommendations of the study will provide decision-makers in preparing a new system (strategy) of hazardous

waste management in Croatia.

Summary: Overall goal of this Project is to analyze different options for the treatment of energy efficiency projects in local budget and to develop clear and unambiguous recommendations for the content of the Ordinance on Treatment of Investment in Energy efficiency Improvements for Budgetary in Croatia. Based on existing research (The analysis and recommendations for local budgets to encourage energy efficiency projects, conducted by the Institute of Economics in 2008 and the Manual for the implementation of energy efficiency projects in the budgets of local (regional) self-administration units, prepared by IMO in 2009) and the implementation of new analysis, the relevant Croatian and European legislation was identified and the requirements arising from them were analyzed. Preparation and implementation of measures envisaged in the Plan of Implementation of the Program's economic recovery may encourage investment in energy efficiency (the private equity investment funds and international financial institutions and EU funds) which can be viewed as an opportunity. On the other hand, removing all barriers to foreign direct investment is one of the medium-term measures. Accordingly, it can be expected that the obstacles to investment in energy efficiency measures will be removed before the third quarter of 2011. The study identifies measures and regulations which should by then be prepared.

Summary: The goal of the project was to analyze the 2009 Annual Programme for Croatia and its coherence with EU strategic objectives and policy goals. The briefing discusses challenges and actions under the political criteria, with specific attention to human rights and minority issues, economic criteria and compliance with the *acquis*.

The conclusion is that the projects planned under IPA 2009 are in line with the EU

policy objectives as set within the enlargement package. The main challenges that could adversely affect the implementation of the programme are the economic crisis and the gap between the adoption and the implementation of the programme. It is recommended that further EU activity in Croatia should also target the Parliament and provide more help for economic reforms. Editorial Board of the journal had changed in 2010. The new editor is Sandro Knezović, Ph.D. and his two new assistants are Marina Funduk and Janko Bekić.

15. Project Support Centre

The Project Support Centre was established in 2010 in order to facilitate the effective application and implementation of research projects, both at national and international level.

In 2010 the main activities of the Centre were directed to provide information, organisation and expert support to IMO's research projects, especially in the application and implementation of international projects. The staff of the Centre participated in the development of project reports for the World Bank, various EU institutions and bodies (European Commission, European Parliament, the EU Delegation in Croatia), NATO, OECD, various UN bodies (UNDP, UNESCO, UNECE) and the Council of Europe and provided support to researchers in the organisation and implementation of applications. The necessary documents were prepared for project applications and the list of references was regularly updated. The staff was involved, especially in organisational and IT aspects, in the development and implementation phases of 40 projects prepared and implemented by IMO, as well as in research implemented for the MSES through 6 research projects.

The Centre also offers ICT support, including computer knowledge skills improvement and research equipment management. The Institute's website (<http://www.imo.hr>) located at IMO's server was maintained and the researchers and scientists daily update the pages with information about their research activities using the Drupal CMS system. The Institute's intranet was also maintained and upgraded (<http://www.imo.hr/egroupware>) which encourages cooperation within and between the activities of research groups. The continuous software and programme applicative maintenance of networked computers under MS Windows XP operating system, computers with Windows 7 operating system and office suite MS Office 2007 and Sophos security protection was installed. Computer and software support and servicing were continuously in use during all events (lectures, round tables, meetings) within IMO.

16. Library and documentation

In 2010 the Library and Documentation Centre performed its regular activities which include the following professional activities: upgrading the collection which covers the review of draft orders, order publications, receipt of publications, including processing library materials (inventory, classification, cataloguing, placement, bibliographic cataloguing-in treatment that means internal cataloguing of bibliographic databases of books, journal articles and documents, and records of the receipt of periodical publications); edit and update pages of the INDOK service at IMO's official online site; the exchange of publications, interlibrary loan, work with in-house and external customers (finding of digital information resources with documents relevant to the work on the MSES scientific projects; teach users to work with online databases and use other sources of information available via the Internet, obtain the required reports on cited papers of individual researchers, assistance in preparing the bibliography and regular reporting on the search of scientific journals of prestigious publishers such as SAGE, monitoring and reporting to individual users about new publications in the field of their work).

The continuation of education of the staff working in an ALEPH collection system, data entry in the specified database, regularly updated Webpac (bibliographic databases on the Internet, i.e. e-catalogues, regular review and write-off of foreign and domestic journals and the establishment of a bibliographic database for IMO's studies) must be emphasized in addition to more important achievements.

Archival service

Further updating of archives and records continued in 2010. The summary list of current records was finalised. Furthermore, the list of all records in the individual organisational units (the Secretariat, the EU i centre, the Library and Documentation) was completed. In the ARHiNET system, the basic funds were entered and the entry at lower levels has continued.

In October 2010 the employee in charge passed the professional examination for working in the archives and thus become qualified to perform this job.

17. "EU i" – Documentation Centre

In 2010 the "EU i" - Documentation Centre continued its primary activity of informing citizens about the European Union and the process of Croatian accession to the European Union, and disseminating the EU documents.

"EU i" maintained communication with customers via telephone, electronic mail and working with those customers who come to the Centre. The structure of users who sought information and documents shows that the most inquiries came from students of undergraduate and postgraduate studies, public administration and the private sector.

In 2010 a significant part of "EU i" activities was implemented through a web portal EnterEurope, a modern means of communication and information that contributes to the recognition of the "EU i"- Documentation Centre and the Institute for International Relations.

The staff of the "EU i" continued with the regular maintenance of the EnterEurope portal whose base of E-point documents has grown to over 10,800 documents. The updating of dynamic content was conducted on a daily basis, including news, announcements of events, documents and tender announcements.

The activities on updating the European Union policies on the portal also continued (Enlargement, External Relations and Foreign Affairs, Science and Research, Audiovisual Policy, Fraud, Energy) and other static content - agencies, review of EU-Croatian relations, etc.).

In 2010 the "EU i" was involved in the project "Information about the European Union for civil society organisations in Croatia" which is being implemented in collaboration with the National Foundation for Civil Society Development.
